1. Main Activities During Reporting Period:

- a. Continuing to develop the following Project related documents for submittal to CTDEEP:
 - i. Investigation Report English Station- Boiler #13 Concrete Foundation and Other Concrete Sampling (Partial)
 - ii. English Station Boiler #13 Interim Remedial Measures (IRM) PCB Remedial Action Report
- b. Continued to evaluate data associated with the processed rock borrow source justification and revised backfill acceptance criteria for the Remedial Action Plans.
- c. English Station Boiler 13 IRM: Between August 14, 2023 and August 16, 2023, Clean Harbors Environmental Services (CHES) performed targeted removal of bituminous pavement and soil beneath a portion of the former water treatment system area. Removal limits were based on results from previous sampling performed in July 2023. Waste generated from this activity was transferred to a lined/sealed roll-off container stored on site. Verification samples for the soil removal area were collected and analyzed for PCBs in accordance with 40 CFR 761 Subpart O and the Work Plan previously submitted to CTDEEP. Analytical results from the verification samples demonstrate that PCBs in excess of 1 mg/kg have been removed, which will allow the area to be restored with bituminous pavement in accordance with the Work Plan.
- d. Vegetation clearing/maintenance activities were performed on August 19, 2023 and August 26, 2023 across the northern portions of the site.
- e. Perform required inspections of:
 - i. Erosion and sediment controls (re)approved under CT DEEP permit number GSN003422 on a monthly frequency.
 - ii. Eight Significant Environmental Hazard (SEH) areas on a bi-weekly frequency.

2. Future Activities:

- a. Submit to CTDEEP:
 - i. Investigation Report English Station- Boiler #13 Concrete Foundation and Other Concrete Sampling (Partial)
 - ii. English Station Boiler #13 Interim Remedial Measures PCB Remedial Action Report
 - iii. Revised Plans and Specifications for Phase 1 Soil Remediation.
 - iv. English Station Boiler 13/14 (High Pressure) Environmental Media Investigation Summary Report

- v. Revised English Station Boiler 1-12 Environmental Media Investigation Summary Report

- b. Continue to work with CT DEEP on approvals needed to move forward with soil remediation activities at the Site.
- c. English Station Boiler 13 IRM activities:
 - i. Coordinate disposal of waste generated from pavement and soil removal activities associated with the area beneath the former water treatment system.
 Restore the work area with bituminous concrete pavement.
- d. Complete annual vegetation clearing/maintenance activities.
- d. Evaluate potential alternatives for Main Power Plant.

3. Site Security:

- a. Continue to maintain the security measures put in place by, and acquired from, the current property owners and as upgraded by UI.
- b. Additional and upgraded security cameras are planned to be installed on the English Station Building in September 2023.
