

The United Illuminating Company Year 4 NRES Small Zero Emission Bid Queue - Feb 2025 RFP

Following the Year 3 August Non-Residential Renewable Energy Solutions ("NRES") Request for proposal ("RFP") solicitation, 0.03600MW remained available to be awarded in the Year 4 February NRES RFP. The United Illuminating Company received Small Zero Bids totaling 3.20790MW during the Two-Week Window, which closed on February 18, 2025, at 1PM EPT. The Bids have been selected according to Section 5.2.5 of the Year 4 NRES Program Manual.
