

The United Illuminating Company Year 5 Feb 2026 NRES Small Zero Emission Bid Queue

Following the Year 4 Aug Non-Residential Renewable Energy Solutions (“NRES”) Request for proposal (“RFP”) solicitation, 0.7765 rolled over into the current RFP resulting in 4.3765MW available to be awarded in the Year 5 Feb NRES RFP. The United Illuminating Company received Small Zero Bids totaling 2.8769MW during the Year 5 Feb Two-Week Window, which closed on February 17, 2026 at 1PM EPT. The Bids have been compiled according to Section 5.2.5 of the Year 5 NRES Program Manual.
