

## **Year 7 SCEF Bid Certification Form**

**for the Connecticut Light and Power Company dba Eversource Energy (“Eversource”) and  
The United Illuminating Company (“UI”)  
Shared Clean Energy Facility RFP**

### **Instructions:**

All capitalized terms not defined herein shall have the meanings set forth in the most recent Request for Proposals for the Shared Clean Energy Facility Program of The Connecticut Light and Power Company and The United Illuminating Company (“RFP”).

**The following three (3) pages must be executed by duly authorized representatives of the Bidder (page 2), Subscriber Organization (page 3), and Owner of the Project Site (page 4), respectively.**

Bidder is defined as the individual or business submitting a proposal (“Bid”) to be considered for selection to be awarded a long-term agreement for the purchase of RECs and energy pursuant to the terms and conditions of a fully executed SCEF Tariff Terms Agreement. The Bidder may or may not be the Subscriber Organization and/or the Owner of the Project Site.

1. Bidder is the individual or business input under “Bidder Information” in Step 1 of 6 in the SCEF online Bid form on the Eversource website. This individual or [an authorized representative of the] business will be required to fill out and sign the Bidder’s Signature, Commitment and Acceptance (Page 2 below).

Subscriber Organization is defined by Section 16-244x of the General Statutes. For the purposes of the Modified SCEF Program Requirements, the term Subscriber Organization refers to the Selected Bidder. The Subscriber Organization may be (i) the customer of record at the revenue meter with site control, (ii) the site owner with consent of the customer, or (iii) the authorized developer with consent of the customer and site owner. The Subscriber Organization may or may not be the Bidder and/or the Owner of the Project Site.

1. Subscriber Organization is the individual or business input under “Subscriber Organization Information” in Step 1 of 6 in the SCEF online Bid form on the Eversource website. This individual or [an authorized representative of the] business will be required to fill out and sign the Subscriber Organization’s Signature, Commitment and Acceptance (Page 3 below).

Owner of the Project Site is defined as the legal owner of the Project site. The Owner of the Project Site may or may not be the Bidder and/or the Subscriber Organization.

2. Owner of the Project Site is the individual or business input under “Owner of the Project Site” in Step 2 of 6 in the SCEF online Bid form on the Eversource website. This individual or [an authorized representative of the] business will be required to fill out and sign the Affidavit of the Owner of the Project Site’s Notarized Signature, Commitment and Acceptance (Page 4 below).
3. **The signature of the Owner of the Project Site (or authorized representative of) must be witnessed by a Notary Public and documented as such.**

**All pages (pages 2, 3, and 4) of this form must be filled out entirely and signed by the appropriate parties, scanned, and uploaded as one single PDF (.pdf) file.**

Bidder hereby certifies that the Project's construction has occurred, or will occur, after the date of the solicitation to which the Bidder is responding and that the project otherwise meets all of the Program requirements.

Bidder hereby certifies that it, or if it is not the Subscriber Organization, that the Subscriber Organization, has the right to use the site described in the Bid Form consistent with the requirements set forth in Section 4, Bidder Eligibility Requirements, of the RFP.

Bidder hereby affirms that the Project's success is not contingent upon Electric Distribution Company ("EDC") assistance in any respect other than execution of the Standard Contract or other services provided by the EDCs on a routine basis to similarly situated projects, such as interconnection.

Bidder represents that it has not received nor sought nor will seek to receive any Connecticut ratepayer-funded incentives or subsidies, including, but not limited to, net metering, virtual net metering, Public Utility Regulatory Policies Act ("PURPA") tariffs, LREC/ZREC contracts, Public Act 18-50 tariffs other than those in this Program, any other contract or program of any kind in which an EDC purchases the Facility's energy, capacity, or renewable attributes, and grants or rebates from the Connecticut Green Bank and any of its predecessors or the Conservation and Load Management Program.
