

## Shared Clean Energy Facility Fact Sheet

In January 2020, The Connecticut Light and Power Company d/b/a Eversource Energy (“Eversource”) and The United Illuminating Company (“UI”, together, the “Electric Distribution Companies” or “EDCs”) launched the Shared Clean Energy Facility (SCEF) Program with the goal of helping provide eligible electric Customers with an opportunity to receive benefits from clean energy sources in Connecticut known as Shared Clean Energy Facilities.

### Shared Clean Energy Facility Program

- Eight-year program that purchases Renewable Energy Certificates (RECs) and energy from eligible projects
- 20-year term for selected projects
- Eligible projects greater than 100kW and less than or equal to 5,000kW are awarded incentive agreements through a competitive solicitation process subject to the price cap below:

#### Year 7 SCEF Bid Price Cap

\$182.94/MWh (\$0.182/kWh)

- SCEF Bids that will be constructed 100% on Solar Carports and/or Solar Canopies can submit Bid Prices above the Bid Price Cap up to but not exceeding **\$304.90/MWh (\$0.304/kWh)**
- One solicitation is conducted annually for the eight year Program. Starting in Year 7 the EDCs will award projects based on a budgetary rather than a MW capacity cap. Year 7 budget caps by company are below:
  - **Eversource** – \$9,864,750.81
  - **United Illuminating** – \$5,709,894.63
- Annual solicitations are conducted through the respective EDCs’ online Bid portals. Bidders must submit all Bid attachments to the EDCs through the relevant portal, available on each EDC’s website (link provided above).

Deadline for Submission of Questions	On or about February 4, 2026
Bid Forms Due	March 4, 2026 by 1:00 p.m. (Eastern Prevailing Time “EPT”), at which time the Pricing shall become firm, irrevocable and binding.

Selection and Notification of Winning Bidders	On or about April 22, 2026
Tariff Terms Agreement Execution	After Selection and Notification of Winning Bidders. Bidders will have to return partially executed Tariff Terms Agreements by the due date established by the Companies which is expected to be approximately 10 businesses days after selection and notification of winning bidders.
Subsequent Rounds of Selection and Notification of Winning Bidders	Approximately 5 business days after Tariff Terms Agreement Execution date (date on which executed Tariff Terms Agreement is due to the EDC for each round of selection). After each Tariff Terms Agreement Execution Date, each EDC will re-evaluate its available budget and reallocate to the next project(s) in the queue as necessary and notify selected Bidders accordingly. This process will continue until the earlier of 1) all available budget is allocated, or 2) May 1, to allow enough time for the EDCs to submit selected bids by July 1.
Tariff Terms Agreement(s) Filed with PURA for review and approval	Within two weeks following the completion of the annual Procurement process.
Commencement of Service	In accordance with Tariff Terms Agreements
